

## Mirage Points Reimbursement System

### Points Allocation:

- 1 pt. Per race (For track events, 1 pt. for first event, .5 pts. for each additional event)
- 1 pt. Per rally
- .5 pt. Per race for local weekly crit series race entered
- 1 pt. For travel to races in excess of 75 miles (Does not apply for rallies)
- 1 pt. For over night stay **required** per race (Does not apply for rallies)
- 1 pt For each volunteer event worked
- 1.5 pt For rally of the month

### Terms and Conditions:

- 1) Points are paid only to members in good standing **with yearly dues being current** in the month of the event requesting points reimbursement.
- 2) The value of each point shall be determined by the monthly dollar allotment divided by the total number of points applied for that month with a maximum value of \$20.00 per point and a maximum point payout for any member of 10 points per month.
- 3) All USAC races, triathlons, duathlons and rallies are eligible.
- 4) Members must wear the current club jersey during the event to qualify for points.
- 5) Travel points shall be awarded one per trip over 75 miles. Rallies are not eligible for travel or over night stay points and only 4 rallies a month maximum.
- 6) Points shall be awarded for participation in qualifying club sponsored activities. The officers shall determine qualifying events.
- 7) Points shall be submitted to the race reimbursement administrator **in person** at the regular monthly meeting. Points are paid for the previous months events only. **Requests for reimbursements from events prior to the previous months events will not be paid.**

### Other:

- 1) The officers, at their discretion may elect to increase points distributions for entries in special or national events.
- 2) Any allocated point money not disbursed in any given month may be added to the next month's points budget or distributed at the end of the year or added to the next year.
- 3) The reimbursement system is intended to promote our sponsors and the participation in competitive and recreational cycling and is not an obligation by The Mirage Cycling Team to anyone. Officers may at any time temporarily or permanently modify the point structure and payout to prevent abuses to the point system.
